INVITATION TO PRE-QUALIFY FOR MAJOR ENGINEERING, PROCUREMENT AND CONSTRUCTION WORKS OF THE SUPPLY & DISPOSAL OF SEAWATER TO THE INDUSTRIAL ZONE OF DUQM, SULTANATE OF OMAN

INTRODUCTION

The Special Economic Zone Authority at Duqm (SEZAD) is seeking to engage an Engineering Procurement and Construction (EPC) Contractor to carry out the Detailed Design (based on Owner provided FEED), Procurement and Construction Works for the new system to supply and dispose of Seawater (cooling water) to the industrial zone of Duqm, Sultanate of Oman.

The Invitation to Tender (ITT) is targeted to be issued to Pre-Qualified companies in Q3, 2015 with award of the EPC Contract. Commencement of the work is planned in Q4, 2015 with handover scheduled for Q4, 2017. The system will provide Seawater to all end users, including the proposed Duqm Refinery which will be built adjacent to the Port of Duqm. The construction of the Seawater system will be schedule-driven.

SEZAD is seeking to prequalify prospective bidders for the EPC Contract. Applicants are invited to obtain the Project Prequalification Questionnaire.

SCOPE OF WORK

The Project Prequalification Questionnaire provides a description of the scope of the work, which includes the following major work packages:

- 1. Marine Intake Structure
- 2. Seawater Pumping Station
- 3. Seawater Supply
- 4. Return Channels & Outfalls
- 5. Beach Well system.

PRE- QUALIFICATION ASSESSMENT

The prequalification of bidders will be based upon previous track record of satisfactory work, taking into account large industrial area seawater cooling system Design and Construction experience in the region and internationally, Organizational structure, Quality Management, HSSE (Health, Safety, Security and Environment) Systems and Financial status. The ITT will include the form of EPC Contract providing for single point responsibility for performance of the entire Work scope. Due to the multi-disciplinary nature of the work scope, major Subcontractors and Joint Venture Corporations will also be considered for pre-qualification.
